We are once again able to offer the <u>DTA's CSA Pilot Program</u> for 2024. We have a <u>\$10 delivery fee</u> per order. Please complete and sign the attached <u>credit card authorization form</u> for this fee to be charged with each confirmed order. All 2024 agreements **will end** in December of 2024. If you wish to continue your CSA share for any part of the 2024 year, this new application must be completed and returned to us by as soon as possible for your share to begin.

Attached is the agreement we have negotiated with DTA. This agreement will allow DTA to charge your SNAP account at the time your monthly benefits are deposited. This will ensure you are able to utilize your HIP benefits each month. HIP benefits vary depending on your household size but are typically a \$40 per month *reimbursement* for fresh produce you have purchased. AutoSNAP charges will automatically be deducted on the same day that your SNAP benefits are loaded into your account. HIP funds are immediately reimbursed to your SNAP account, however, please note that if you have already used your HIP benefit within the calendar month, your autoSNAP payment will be rejected and you will need to make other payment arrangements.

Please **READ THE AGREEMENT CAREFULLY.** These are DTA policies and they will be followed. There can be no refunds, exchanges or returns.

You can sign up for any **one** of the share options that best fits your needs:

**\$40 per month Shares:** (you will need to select only **ONE** of these options on the agreement)

- a) Mixed Produce Share: about 20 pounds of fresh produce, 7 9 items per box
- b) Mix Apple Share: about 20 pounds of apples, 2 4 varieties per box
- c) Mixed Mushroom Share: about 3 pounds of mushrooms, 2 4 varieties per box
- d) Free Choice Share: you select from seasonal produce, about 10 20 pounds/4 10 items

## \$60 per month Free Choice Share:

• You select from seasonal produce, about 15 – 30 pounds/6 – 15 items per box

## \$80 per month Free Choice Share:

• You select from seasonal produce, about 20 – 40 pounds/8 – 20 items per box
